Cookie Policy

Our website <u>https://www.colourlovers.com</u> (the "Website") uses cookies. In this cookie policy, we explain in detail what cookies we use, for what purposes we use them and how you can decline our use of cookies. 1. Responsible entity (data controller)

2. What is a cookie?

A cookie is a small piece of data or a text file that is downloaded to your computer or mobile device when you access certain websites. Cookies may contain text that can be read by the web server that delivered the cookie to you. The text contained in the cookie generally consists of a sequence of letters and numbers that uniquely identifies your computer or mobile device; it may contain other information as well.

3. What types of cookies are there?

There are several types of cookies, namely:

• Strictly necessary cookies. These cookies are necessary for proper functioning of the website, such as displaying content, logging in, validating your session, responding to your request for services, and other functions. Most web browsers can be set to disable the use of cookies. However, if you disable these cookies, you may not be able to access features on our website correctly or at all.

• Performance cookies . These cookies collect information about the use of the website, such as pages visited, traffic sources, users' interests, content management, and other website measurements.

• Functional Cookies. These cookies enable the website to remember a user's choices – such as their language, user name, and other personal choices – while using the website. They can also be used to deliver services, such as letting a user make a blog post, listen to audio, or watch videos on the website.

• Marketing cookies. These cookies allowwebsiteoperators to create, implement, and examine their digital marketing campaigns. Such cookies allowthem to reach the right customers, analyse the productivity of their marketing campaigns, and offeryoupersonalisedadvertisement.

• Preference cookies. These cookies enable a website to remember information that changes the way the website behaves or looks, like your preferred language or the region that you are in.

• Advertising or targeting cookies. These cookies are usuallyplaced and used by advertisingcompanies to develop a profile of yourbrowsinginterests and serve advertisements on otherwebsitesthat are related to yourinterests. You willseelessadvertising if youdisablethese cookies.

Session Cookies. These cookies allowwebsites to link the actions of a user during a browser session. Theymaybeused for a variety of purposes, such as rememberingwhata user has put in their shopping cart as theybrowse a website. Session cookies also permit users to berecognized as theynavigate a websitesothatany item or page changes theymake are rememberedfrom page to page. Session cookies expire after a browser session; thus, they are not stored long term.
Persistent cookies. These cookies are stored on a user'sdevice in between browser sessions, whichallows the user'spreferences or actions across a site (or, in some cases, acrossdifferent sites) to beremembered. Persistent cookies maybeused for a variety of purposes, includingrememberingusers' choices and preferenceswhenusing a website or to targetadvertising to them.

4. Cookie consent
